PREFACE

The origins of this book were in a workshop held in Beijing in May 2006, sponsored by the China Institute for Science and Technology Policy (CISTP) of Tsinghua University, Beijing; the Industrial Technology Research Institute (ITRI), Hsinchu; and the Administrative Committee of Zhongguancun Science Park, Beijing. Later workshops that developed some of these themes were held at Stanford University in November 2006 and in Taipei in September 2007.

We are grateful to the contributors to this volume, to the organizers of the meeting and especially to Professor Lan Xue of Tsinghua University, Madame Mulan Zhao of the Administrative Committee of Zhongguancun Science Park, and Tze-Chen Tu, general director of ITRI's Industrial Economics and Knowledge Center (IEK).
